**The Division of Gastroenterology, Hepatology and Nutrition at the University of Pittsburgh School of Medicine and the University of Pittsburgh Medical Center (UPMC) invites applications for a full-time Inflammatory Bowel Disease gastroenterologist faculty position at the junior, mid-level, or senior position.**

**We are seeking a full-time, BC/BE gastroenterologist to expand the Division's IBD Center.** The candidate will have or be eligible for an unrestricted medical license in the Commonwealth of Pennsylvania. This position requires an MD/DO from an accredited, recognized university (or foreign equivalent). Academic rank, tenure and salary will be commensurate with experience.

**The successful candidate will possess** clinical and personal skills to facilitate clinic and inpatient consultations, teaching of gastroenterology fellows, and supervision of physician extenders within a large, dynamic academic medical center. Qualified candidates will have an academic focus on clinical care, research, or education. Commitment to interactive multi-disciplinary care models such as a medical home, skilled performance of routine endoscopic procedures, and advanced interpretation of IBD diagnosis and patient care are expected. A record of research investigation is highly desirable.

The **Division of Gastroenterology, Hepatology and Nutrition** possesses strong translational programs of clinical and research excellence in IBD, pancreatic disease, GI cancer, disorders of GI motility, hepatology, and transplant medicine. With 63 faculty, advanced and internationally recognized clinical and research initiatives, and a multidisciplinary focus on innovation, leading-edge technologies, and education, the Division is among the top collaborative academic GI groups in the U.S.

### **Highlights of our program offer include:**

- New opportunities to be innovative and grow an IBD Center within an integrated financial and delivery system, which includes the UPMC Health System (>40 hospitals) and the UPMC Health Plan (>4 million subscribers).
- Research support, including start-up funds.

- Opportunity to work within the IBD Medical Home (one of the first of its kind) with integrated behavioral, nutritional, and care management with an ongoing, active \$6 million in research funding.

The **Department of Medicine** has 665 full time faculty in 10 divisions. The Department of Medicine supports a broad array of exceptional research programs featuring many nationally known academic physicians and scientists. The Department of Medicine is one of the most balanced in the U.S. related to clinical/research stability. It's basic, translational, and clinical research programs continue to grow rapidly, with the FY19 research expenditure over \$102 million. The Department of Medicine's NIH funding level is consistently ranked within the top 10 nationally, among other Departments of Internal Medicine.

The **University of Pittsburgh** and its principal partner, the **University of Pittsburgh Medical Center (UPMC)**, together have raised the standard of scientific and medical excellence in the Pittsburgh region and have positioned biomedical science and health care as a driving force behind the region's economy. Currently, the School of Medicine and affiliated health sciences is ranked 5<sup>th</sup> in NIH funding. As a result, the University has invested significantly in new research infrastructure and faculty recruitment.
